#### **CHAPTER I**

### **INTRODUCTION**

The positive face of the teacher can be threatened, because of the question submitted by students which contain criticism, disagreement, and accusations. The negative faces of students can be threatened too because the teacher's speech contains orders, warnings, advice and threats.

In the classroom, teachers always teach the students how to interact either directly by giving the students motivation or indirectly by giving the students good model to interact each other. It was important to put politeness in interaction. Politeness was not only influenced by polite utterances that has used to communicate with each other, but politeness also influenced by face.

Politeness in language is one of the objects of pragmatic studies. Pragmatics itself is a branch of linguistics that discusses the use of language in the communication process (Levinson, 1962). Therefore, pragmatic theory is considered suitable for understanding problems, analyzing data, and describing the results of data analysis on how to behave in a polite language, including how to behave politely in minimizing speakers' coercion on speakers.

According to Glaser (2009) in Ayu (2018), the speaker communicative competence deals with pragmatics. Pragmatics determines our selecting of wording and our interpretation of language in different situation. Such as the awareness of how we modify conversation when addressing different types of listeners. When you ask someone to do something for you, you do not say directly "move your bag", but you usually want to do this politely. For example: "sorry to bother you" used for politely asking someone to do something for you, especially someone you do not know: Sorry to bother you, but would you mind moving your bag?

The reason of the researcher why choose this title is the researcher interest to analyze the use of politeness strategies used by teacher in the classroom. So the researcher chosen two English teacher of SMP Negeri 2 Kota Ternate to be the subjets. The researcher wants to know what politeness strategy use by the teachers. Do they only used 1 politeness strategies or fourth strategies by Brown and Levinson. What the effect if teachers speaks impolitely to the students, will the students feel okay when the teachers says 'hey stupid' or the words are not polite or unworthy to accept by students. The politeness strategies by Brown and Levinson are: Bald on record, Positive politeness strategy, Negative politeness strategy and off record.

Based on the background above, the researcher conducted a research by the tittle "An Analysis of Politeness Strategies Used by Teachers in the Classroom at SMP Negeri 2 Kota Ternate".
