The song "I Want to Break Free" by The Queen has been a controversial song in the 1970's. the lyric became the power of people that era, because they believed that that lyric is to express the minority's voice. In Europe, people rejected them to perform because the people were upset with the Queen. It all because the video music alike shows the symbol of LGBT which has been known as the lifestyle of their vocalist, Freddie Mercury. According to Pradopo (1997: 137 in F. Lafamane: 2020), language style is a special way of language used to get certain effects in a literary work. According to Keraf (2010: 23 in Eliyani: 2022), language style is a way of expressing someone's thoughts through language specifically that can show the soul and personality of the language user.
