CHAPTER I

INTRODUCTION

A. Background of the research

Literature is also the product of creative literature and thought of human life. Literature is also the result of conveying ideas and views about human life which are proured creatively and packaged in beautiful forms by writers. This is in accordance with the opinion axpressed by Semi in (Siska 2013:1), that literature are creativity works must be able to give birth to a beautiful creation and try to channel the needs of human beauty. One type of literary work is novel and one of the common problems that is also contained in the novel is the gender problem.

Gender is the nature of fibers, the role that is naturally attached to male and female. In everyday life is often gender injustice such as commonly violent in people who are considered weak in this case women, sexual harassment, and so on. It is based on the explanation that the women is a two-sided figure. On one side, women is beauty. Her charms can make men crazy about. On which side Others, she was considered weak, so that weakness is used as a reason by malicious men to exploit its beauty (Sugihastuti 2010:32). That's what caused the birth of gender injustice. Gender injustice itself manifested in various forms, marginalization, subordination stereotype, violence, dan double load.

The novel is a prose literary work that has broader, accurate composition of sentences, the language used in the novel being the everyday language that allows readers

to readily understand the content of the novel, and even people who have never had a literary education can understand a novel. Literary novels must also have interesting stories, varied stories and positive knowledge for readers. Nurgiyantoro (2010:10) suggests that novels are a work of fiction that the built by the elements of builders, namelly the intrinsic element and extrinsic elements. The novel can also be interpreted as a prosa contains a series of person's life stories with others around it by highlighting the character and nature of the perpetrator.

Memoirs of a geisha by Arthur golden chosen as the object of the research because this novel tells about of a child named Chiyo who comes from the poor small fishherman village and named Yoroido. Chiyo lived with her parents and her older sister, Satsu. But, because of the poverty and the parents were growing old, his father sold Chiyo and Satsu to someone to be brought to Kyoto in the Gion district.

Memoirs of a Geisha invites us into the geisha world, where appearance is very important, where a girl's virginity is auctioned off to the highest bidder, where women are trained to attract the most powerful men. The story of Chiyo, or Sayuri, who was known as Sayuri in a poor fisherman village in 1929, when as a 9-year-old girl, with remarkable blue-gray eyes, she was sold to a famous geisha's home. Unable to bear the life of the house, she tried to escape this act put her in danger of becoming a servant for life. As she mourned her fate on the bank of the river Shirakawa, she met Iwamura Ken, this man approached and comforted her. At that time sayuri was determined to become Geisha, only to have the opportunity to meet that man one day.

Through Sayuri, the reader have witnessed the plight of women who have studied the heavy arts of geisha, singing and dancing, wearing kimonos, thick makeup, and complicated hair makeup compete with fellow geisha. But when world war II broke out, and geisha houses had to be closed down, Sayuri with little money and less food had to start again from scratch.
