#### **CHAPTER I**

## INTRODUCTION

# A. Background of The Research

In everyday life in society and in the school environment, language is one of the tools to communicate both directly and indirectly. Uniquely, we can understand that the use of language is not easy. Other problems faced by language users include fear of using language, namely fear of being wrong, vocabulary, understanding vocabulary both lexically and grammatically. Alwasilah (2011:95), stated the components in linguistics cover various fields, namely phonetics, morphology, syntax and semantic. In this research, the field of study to be studied is morphology.

According to Aronoff (2011), Morphology refers to the mental syste involved in wod formation or to the branch of linguistic that deals with words, their internal structure, and how they are formation, including the ways new words are coined in the language of the world, and the way forms of words are varied depening on how they are used in "sentences. Morphology is the study of the combination of morphemes to yield words (Haspelmath, M,2010). Furthermore, Morphology is the study of words and how they are formed.

Bauer (2007), morphology is about the structure of words, how word such as dislike is made up of smaller meaningful elements such as dislike. Learning english morphology essential for the students of English departement because english morphology supports the language teaching. English morphology also supports language elements (grammar, vocabulary) and language skilss (reading, writing, nd speaking).

In studying morphology, we are familiar with the term morpheme, where the meaning of morpheme is the smallest unit of form in a word that still has meaning. Morphemes have several types. Based on whether or not they can be directly used in phrases or sentences, morphemes are divided into two: free

morphemes and bound morphemes. Free morphemes are morphemes that, without combining with other morphemes, can already be used in phrases or sentences. Meanwhile, bound morpheme cannot exist independently without being joined or added to another morpheme.

Identifying a morpheme is very difficult, because there are several things that need to be understood, for example singer consists of two morphemes ( sing is a free morpheme and –er is bound morpheme because it cannot be used without being attached to another morpheme. )

The potential of the students in morphological still lack, it proven from their performance in recogniting and controlling the morphemes. It refers to the students comprehension of morphologically complex terms and their ability to develop new meaning of word.

In the opinion of morphology lecturer, students still do not fully understand how to use / analyze free and bound morphemes, for example in the use of morphemes; They do not understand which morphemes are still possible to add, or indeed which part of the morpheme should be the end of a word. They don'tknow that the addition or subtraction of a particular morpheme would bring about a change in meaning, even the type of word of which the morpheme is part. It looks very simple, but this simple thing will eventually hinder students' progress in mastering subjects that have something to do with morphemes.

Based on the explanation above, researcher is interested in analyzing the competence of fourth semester students in using free and bound morphemes. The ability of students in the use of morphemes will greatly help them in mastering the grammar and meaning of a sentence or speech in language.

## B. Scope of The Research

The scope of this study is focuses on the morphological process in free and bound morpheme. The subject of this research is students of the English department in the fourth semester at the University of Khairun University. In this research, the writer analysed student's competence in using free and bound morphemes.
