

ABSTRAK

Marwiyah Muhtar, 02271711141. Evaluasi Efektivitas Pengelolaan Dana Desa Di Desa Samo Kecamatan Gane Barat Utara, dibimbing oleh Rusman Soleman (pembimbing I) dan Zulkifli Abu (pembimbing II).

Penelitian ini bertujuan untuk mengevaluasi pengelolaan dana desa di desa Samo Kecamatan Gane Barat Utara Kabupaten Halmahera Selatan. Penelitian ini menggunakan pendekatan kualitatif deskriptif, peneliti melakukan wawancara pada 5 informan di desa samo yaitu: kepala desa, sekretaris desa, bendahara desa, tokoh masyarakat dan ketua BPD. Berdasarkan hasil penelitian ditemukan bahwa pemerintah desa telah merealisasikan anggaran dana desa yang dikelolah untuk pembangunan desa namun belum sesuai dengan kebutuhan desa dan masyarakat setempat sehingga pengelolaan dan pembangunan desa dengan dana desa belum efektif hal tersebut dapat dilihat dari kinerja pemerintah dan juga partisipasi masyarakat sangat minim, alasan masyarakat kurang berpartisipasi karena pemerintah tidak transparan terkait anggaran dana desa, dalam hal ini masyarakat tidak dilibatkan dalam forum musyawarah sehingga masyarakat kurang berpartisipasi dalam perencanaan APBDes yang dibuat. Selain itu karena kurangnya komunikasi dan juga sosialisasi sehingga sebagian masyarakat bahkan kaur pemerintah tidak transparan dalam pengelolaan anggaran desa.

ABSTRACT

This study aims to determine the effectiveness of village fund management in Samo Village, North West Gane District, South Halmahera Regency. This study uses a descriptive qualitative approach, the researcher conducted interviews with 5 informants in Samo village, namely: village head, village secretary, village treasurer, community leaders and head of BPD. Based on the results of the study, it was found that the village government has realized the village fund budget allocated for village development but has not been in accordance with the applicable government regulations so that the development and management of village funds has not been effective, this can be seen from the performance of the government and also the participation of the community is very minimal, the reason for the lack of community participation is because the government is not transparent regarding the village fund budget, In this case, the community is not involved in the deliberative forum so that the community is less involved in the planning of the APBDes that is made. In addition, due to the lack of communication and socialization, some people and even the government do not understand related to the allocation of village funds, how to manage the village budget effectively. Therefore, it is hoped that the government and the community must jointly increase awareness and understanding for future village development.
