

ABSTRAK

Tujuan penelitian, yaitu: (1) Menganalisis efektivitas pengelolaan dana desa di Desa Baru dan Desa Akegula. (2) Mengidentifikasi faktor yang mempengaruhi efektivitas pengelolaan dana desa dalam mendukung pemberdayaan masyarakat. (3) Mengevaluasi peran serta masyarakat dalam pengelolaan dana desa di Desa Baru dan Desa Akegula.

Metode penelitian yang digunakan yaitu metode penelitian kualitatif yang bersifat deskriptif untuk memberikan gambaran secara jelas mengenai masalah-masalah yang diteliti serta melakukan wawancara dengan 14 informan.

Hasil penelitian menunjukkan bahwa: (1) Efektivitas Pengelolaan Dana Desa di Desa Baru belum efektif sedangkan di Desa Akegula sudah dapat dikatakan efektif. (2) Faktor yang mempengaruhi efektivitas pengelolaan dana desa, yaitu berada di Pemerintah Desa Baru, karena kurangnya pemahaman terkait pengelolaan Dana Desa terhadap pembangunan. (3) Peran masyarakat dalam proses pengelolaan dana desa dalam mendukung pemberdayaan masyarakat sangat penting bagi pemerintah desa, karena keterlibatan masyarakat akan berkontribusi terhadap kualitas perencanaan program desa dan pemberdayaan masyarakat.

ABSTRACT

The objectives of the research carried out are: (1) Analyze the effectiveness of village fund management in Baru Village and Akegula Village. (2) Identifying factors that influence the effectiveness of village fund management in supporting community empowerment. (3) Evaluate community participation in managing village funds in Baru Village and Akegula Village.

The research method used is a descriptive qualitative research method to provide a clear picture of the problems being studied as well as conducting interviews with 14 informants.

The research results show that: (1) The effectiveness of village fund management in the Village cannot yet be said to be effective, whereas in Akegula Village it can already be said to be effective. (2) Factors that influence the effectiveness of village fund management are in the New Village Government, due to a lack of understanding regarding village fund management towards development. (3) The role of the community in the village fund management process in supporting community empowerment is very important for the village government, because community involvement will contribute to the quality of village program planning and community empowerment.
